

## ATTORNEY/TRUSTEE/U.S.TRUSTEE ACCESS BANKRUPTCY EVENTS GLOSSARY:

● **Utility/Functions Key:**

**relates** – ability to relates to previously docketed pleading

**sched** – ability to set a due date or hearing, i.e. answer, response, objection to plan, etc.

**term** – ability to terminate a deadline or hearing

**records** – screen presented that allows user to record specific information, i.e. fee information, claim information, etc.

**prefix** – pull-down list of prefixes displayed for inclusion in docket text, i.e. amended, joint, etc.

**text** – box that allows user to insert free text in docket text

**flags** – event will set a case flag, i.e. fees
